The Technical & Financial Evaluation of the product(s) will be carried out by the concerned procuring agency (District Health Authorities/Health Facilities/Vertical Programs), under administrative control of Primary & Secondary Healthcare Department and by Punjab Emergency Services (Rescue 1122), under 64(a) PPR 2014, by inviting Technical & Financial Proposals through Request for Proposals (RFPs) as per Rule 38(2)(a) of Punjab Procurement Rules 2014 and subsequently AAT, Contract Agreement, Purchase Order, Receiving of Stock, Inspections and Payments will be made by concerned procuring agencies.
- 6. After inviting the bids from notified prequalified pool of firms, the items not finalized will be procured through open competitive bidding as per Punjab Procurement Rules 2014 by the procuring agencies of P&SHD.
- 7. For items not listed in this notification out of the list advertised in prequalification, the procuring agencies will opt for open competitive bidding as per Punjab Procurement Rules 2014.
