

INVALIDATION CERTIFICATE

Certified that we have carefully examined Mr. Haji Muhammad Usman S/O Allah Bakhsh working as **Security Guard (BS-01) Govt. Elementary School Dana Durrannah**. His/Her age according to his/her own service record is 59 years and by appearance is about 59 years. The brief clinical findings are: -

Patient Mr. Haji Muhammad Usman S/O Allah Bakhsh, was presented in Medical Board with C/O pain back with radiations and difficulty of walking. On examination, patient had decreased forward bending, lateral bending and rotation of spine (cervical, Lumbar) SLR Rt. 70°, left 50°. Sensations reduced in L3, 4-5 areas on Rt. Side power 4/5 in lower limbs.

There was osteoarthritis of lumbosacral spine in Consultant Radiologist report DHQ Hospital Muzaffargarh and circumferential disc bulge, posterior annulus tear and ligamentum flavum hypertrophy at L4-L5 causing thecal sac compression, bilateral lateral recess narrowing. Bilateral traversing and exiting nerve roots impingement on MRI report of Radiologist Nishtar Hospital Multan.

Patient was referred to Professor of Neurosurgery/HOD Nishtar Hospital Multan vide letter No. 7018/DHQ dated 14-11-2022. As per opinion of Dr. Syed Zahid Hussain Shah, Associate Professor/HOD of Neurosurgery NHM vide No. PTS/Invalidation/52807/NH dated 24-11-2022 and No. PTS/Board/3422/NH dated 18-01-2023, patient has O/E bilateral partial foot drop. On MRI DSD and multilevel spinal stenosis and patient can be invalidated on this medical ground.

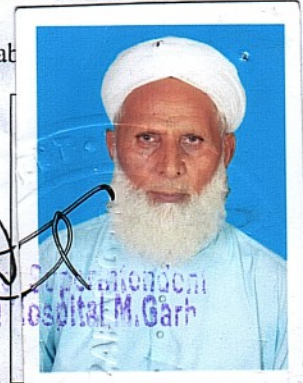
On basis of patient history, Clinical Examination, Radiologist opinion, DHQ Hospital Muzaffargarh, MRI reported by Radiologist NHM and Professor of Neurosurgery/HOD, Nishtar Hospital Multan, patient can be invalidated on this ground in category "B".

We consider her to be invalid as a consequence of the diagnosis of "Prolapsed intervertebral disc L4.5".

The invalidation category assigned is "B"

- A. Completely and permanently for further service of any kind.
- B. Completely and permanently incapacitated in the department to which he / she belongs.
- C. Incapacitated for further service in the appointment which he /she holds, but we are of the opinion that he/she is (or many after resting _____ months he) fit for services of less Laborious character than which he/she has been doing.

His/her incapacity does not appear to us to have been caused by irregular or intemperate habits. Thumb and finger impression of the examined person if any a gazetted Officer.
