**PLAN:-**

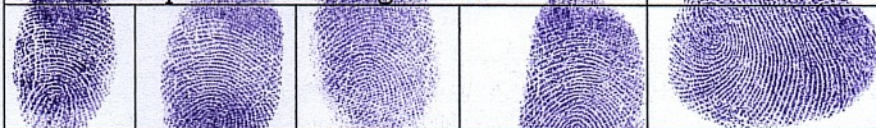
**He is very symptomatic, despite taking medical treatment. His disease is progressive in nature. His is invalidated from Govt: service and placed in category "A".**
