Certified that we have carefully examined **Mr. Muhammad Tanveer Ahmad S/o Muhammad Sarwar, Warder No.4763 of the District Jail Toba Tek Singh**. His age according to his service record is 44-year & 10-month (22.10.1977) and by appearance is about some age.

**On Examination:-** Comminuted fracture of right distal, he is unable to walk without support, he is also case of Osteoarthritis, refer to Allied Hospital Faisalabad for Expert Opinion.

**The brief clinical findings are** \*According to the expert opinion of Dr. Rana Dawood Ahmad Khan, Associate Professor HOD Orthopedic Department Faisalabad, received from Medical Superintendent, Allied Hospital Faisalabad vide letter No.1158/29211/AHF/22 dated 16.06.2022, The Patient had multiple surgeries around knee and now cannot flex the knee and cannot walk without support. He can be put in the Category "B" of invalidation on medical Grounds.

We consider him to be invalidated as a consequence of the diagnosis of:-

- **Multiple surgeries around knee due to which cannot flex the knee.**
- **He is unable to walk without support.**

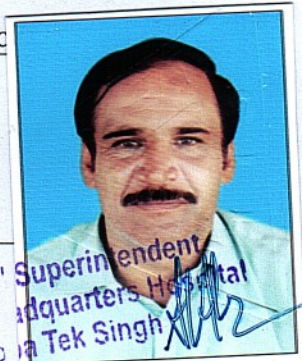
(A)- Completely and permanently incapacitated for further service of any kind.

(B)- Completely and permanently incapacitated in the department to which he/she belongs.

(C)- Incapacitated for further service in the appointment, which he/she holds, but we are of the opinion that he/she is (or may after resting for \_\_\_\_\_ months be) fit for service of less laborious character than which he/she has been doing.

His/her incapacity does not appear to us to have been caused by irregular or intemperate habits.
