Also having Osteoarthritis knee joints since last 02 years. He complains of burning and tingling sensations in hands & feet, numbness in toes of both feet.

On examination, well oriented male, of average built, vitally stable. Crepitus is felt in both of knee joints. There are hair loss changes on both shins upto knee joints. Impaired fine touch in both legs, upto half of the calf. Ankle jerk is slightly diminished on both sides. Pulses are equally palpable on both sides.

LABS:- Hb A1C 7.5 % dated 29-11-2021. ALT = 82 U/L, CBC= N, RFT=N, UCE= Sugar +1, Alb=Nil, RBC's & Pus= Nil. ECG, CxR & USG Abdomen in normal limits.

X-ray knee joints show early degenerative changes in both knee joints.

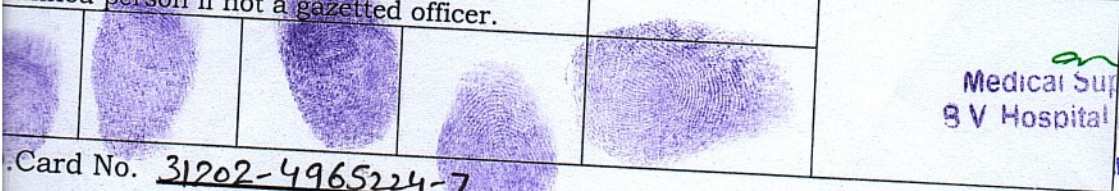
OPINION:-

He is a case of poorly controlled diabetes alongwith, hypertension and Osteoarthritis. He is also suffering from diabetic poly neuropathy, which is chronic progressive and irreversible disease. Hence, he is invalidated assigning the category "B".
