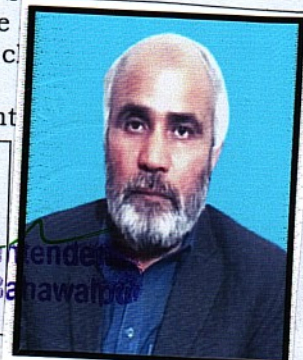
-Nadir Mustafa S/O Malik Muhammad Deen with NIC No. 31202-6098465-5 is known case of Hypertension, Diabetes Mellitus, Ischemic Heart Disease. He has complaint of chest pain on mild exertion relieved by sublingual angisid. He is taking treatment regularly. His coronary Angio was done in 12th April, 2017 which showed Tripple Vessel Disease with left main stem involvement + normal LV function and CABG was advised at that time. His CABG was done. He had history of hospitalization after CABG with Post -CABG Angina. His Echo (01-06-2017) showed normal LV size with mild LV systolic dysfunction (EF-45 %) with segmental wall motion defects. Now he has compliant of recurrent chest pain on routine activity and relieved by medicines.

PLAN:-

Despite taking treatment, he is still symptomatic. His disease is progressive in nature. He is invalidated from Govt: service and placed in category "B".

WE CONSIDER HIM TO BE INVALID AS A CONSEQUENCE OF THE DIAGNOSIS OF TRIPPLE VESSEL DISEASE, HYPERTENSION, DIABETES MELLITUS + ISCHEMIC HEART DISEASE. THE INVALIDATION CATEGORY ASSIGNED IS "B".
