MINUTES OF MEETING OF THE GRIEVANCE REDRESSAL COMMITTEE HELD ON 03th DECEMBER, 2020 AT 11:00 A.M TO REDRESS THE GRIEVANCE APPLICATIONS OF THE FIRMS AGAINST EVALUATION REPORT FOR THE PREQUALIFICATION OF PHARMACEUTICAL MANUFACTURING UNITS AND SOLE AGENTS OF FOREIGN PRINCIPLES OF SURGICAL DRESSINGS FOR THE FY 2020-21

Answer: As per PQD evaluation criteria we have to submit Valid DML/ License to Manufacture Medical Devices on form-3 /License to Import Medical Devices on form-4 Valid DML/ License to Manufacture Medical Devices on form-3 /License to Import Medical Devices on form-4 issued by DRAP.any one of above is a accepted. We have already attached Valid DML along with our PQ application. But it was not considered by technical committee. As per drug act/DRAP act duration of licence to manufacture drugs is valid for period of 5 years. "Duration of a licence to manufacture drugs: A licence issued under this Chapter shall, unless earlier suspended or canceled, be in force for a period of five years from the date of issue and may thereafter be renewed for periods of five years at a time: Provided that an application for renewal shall not be entertained unless it has been made within sixty days after the expiry of the licence and when an application has been made as aforesaid the licence shall subject to the orders passed on the application for renewal continue in force for the next period of two years. Provided further that duration of a licence issued under rule 21 shall be two years unless earlier suspended or canceled." Before expiry period we have applied for renewal and as per law our DML is valid. DRAP has also issued our firm for latest GMP for manufacture of drugs and medical devices separately on the same DML having No.000514 which means our DML is valid. DRAP has also issued our firm for latest GMP for manufacture of drugs and well as medical devices having same Manufacturing licence N	Mr. M. The committee heard the viewpoint of the firm which was examined in the light of Evaluation Report. The committee after due deliberation and discussion, keeping in view the required parameters in detail decided that: 1. The firm provided valid DML which was accepted. 2. The firm submitted valid bank statement of FY 2019-2020 on its title account which was also accepted. 3. The firm submitted valid registration from with chamber of commerce which was also accepted. 4. The firm submitted purchase orders for relevant 3 years for the quoted item which were also accepted.
